Maryland's First Live Photo-documented Chestnut-collared Longspur, Calcarius ornatus

On 31 January 2015, we were slowly driving through the snow-covered farm fields of Washington County when we observed a small brown bird on the side of Chewsville Road. Our first impression suggested a Lapland Longspur (*Calcarius lapponicus*), but the bird's face appeared buffy and the auricular pattern less distinct than that species. The bird was feeding along the snowless area next to the road and in a strip of longer grass. Traffic was fairly heavy and every few minutes a car would drive by and the bird would flush, fly around, and eventually return to the roadside. It often gave a rattle call as it flushed. We viewed the bird with binoculars from about 30 to 50 m (~100 to 160 ft), and were able to obtain some photos and video. We watched the bird from about 1:00 p.m. until 1:30 p.m., until it was flushed by a passing car, flew up over a hill, and did not return.

Our photos showed blackish feathering around the breast, very short primary projection, no rufous in the wings, and extensive white in the tail, field marks of a male Chestnut-collared Longspur (*Calcarius ornatus*) in basic plumage. We sent out some poor snaps off the back of Feild's camera which allowed Matt Hafner and several others to confirm the identification. We then posted information of the sighting to the Maryland & DC Birding listserv (Feild 2015, Green 2015). We returned several more times during the day but were unable to relocate the bird.

On 1 February, about 20 people arrived early hoping the bird would return. The first sighting of note was a Rough-legged Hawk (*Buteo lagopus*) that spent the day in the area. At about 8:30 a.m., the Chestnut-collared Longspur was refound several hundred meters from its previous location. It remained in this general area, in a small grassy patch near several fence posts, where it provided good views to many observers until at least 4:10 p.m. (Figures 1 and 2). It was also reported by one observer on 2 February, just after 9:00 a.m. There were many photographs taken during the three-day sighting that provided additional documentation of the bird (eBird 2015, Maryland Biodiversity Project 2015).

There are 42 reports of the Chewsville Road bird on eBird for 1 February, plus one report for 2 February, the last report of which we are aware (eBird 2015). It is likely that as the snow melted, the bird simply moved away from the road. 31 January was a cold day with the temperature remaining below freezing and little snow melt. Away from the road the ground was almost completely snow-covered. 1 and 2 February were warmer and sunny, with temperatures as high as \sim 7 °C (~44.6 °F), and large areas of ground were soon snow free. This created an abundance of habitat for a very small brown bird.

The 2015 Washington County sighting was accepted by the Maryland/District of Columbia Records Committee (MD/DCRC) (Phil Davis, in litt., 27 August 2015).

PREVIOUS MARYLAND RECORD AND REPORT

There are two previous reports of Chestnut-collared Longspur in Maryland.

There is an accepted record of an adult male specimen that was collected by Captain Annsley Ludlam "on the Thoroughfare farm just beyond the drawbridge across Assateague Bay" at Ocean City, Worcester County, on 20 August 1906 (Kirkwood 1908, MD/DCRC 2015b). The specimen is housed in the Division of Birds, Department of Vertebrate Zoology, National Museum of Natural History, Smithsonian Institution, Washington, DC.

There was also a sighting by Harold Wierenga at Sandy Point State Park, Anne Arundel County, on 30 October 1970. The bird was subsequently observed on 31 October by Harold Wierenga, Chan and Eleanor Robbins, Carl Carlson, Paul DuMont, Arthur Alexander, and Bill and Fran Pope (Wierenga 1970). This record was not accepted by the MD/DCRC. The decision summary states: "Some reviewers felt that the written description was not detailed enough, especially regarding colors and patterns of the head, upperparts, and tail plumage. The addition of the field notes taken at the time was appreciated, but proved insufficient to overcome the reviewers' doubts. Chan Robbins has been unable to locate his field notes for this sighting; if they come to light the record can be reconsidered." (MD/DCRC 2015a).

NORTHEAST AND ATLANTIC COAST RECORDS

Table 1 summarizes the various state records committee-accepted records of Chestnut-collared Longspurs in the Northeast and Atlantic Coast states. There are 26 accepted records for this region, with records from 10 of the 17 constituent states. The first is from 1886, and the most recent prior record from June 2012. Since 1968, there have been records, on average, every 2.5 years. The records are fairly evenly spread throughout the year, with records in every

month except July. There are 6 records from June, more than in any other month. The majority of the records are from coastal locations, so the Washington County record is noteworthy in that it was roughly 250 km (155 mi) from the coast.
