Common Loon Conference—The North American Conference on Common Loon Research and Management, sponsored by the National Audubon Society and hosted by Syracuse University, was held 12–14 August 1977 at the Minnowbrook Conference Center, Blue Mountain Lake, N.Y. Priorities determined by the participants included: (1) establishment of an informal working group to serve as a clearinghouse for information on research and management efforts, (2) collection of historical loon nesting records for assessment of recent range contraction or expansion by this species, (3) coordination and standardization of breeding surveys and an effort to document the current breeding status of the loon, particularly in the northeastern U.S., and (4) expanded research, including increased banding efforts and initiation of a winter banding program.

The working group, consisting of Judith W. McIntyre of Syracuse University, Richard L. Plunkett of the National Audubon Society, and Rawson L. Wood of the Loon Preservation Committee of the Audubon Society of New Hampshire, plans another meeting next year. Request for Information on Cowbird Nestlings—I am studying geographical variation in the gape coloration of nestling Brown-headed and Bronzed cowbirds. In some localities the rictal flanges and tomia are yellow, in other areas they are white. A preliminary report on this study will appear early in 1978 in the Auk. Since more information is needed, I would greatly appreciate receiving the following types of data from any location: coloration of the rictal flanges, tomia, mouth interior and eye-lids of cowbird and host nestlings (if the latter are present), host species, precise locality data, and date. The information on coloration is best if based on observations of live nestlings but colored photographs are also valuable. My studies would benefit if I had the opportunity to inspect personally colored photos but this is not a necessity. Most nestlings will probably have rictal flanges and tomia that can be described as clearly yellow or clearly white but if you wish to report data with greater accuracy, and especially if the color seems intermediate, the nestling cowbird can be compared against a color standard. Pages 250 and 251 in "Birds of North America" by Robbins et al. show the heads of warblers and present numerous shades of yellow. These shades of yellow (or others appearing in Robbins) can be matched with those of live nestlings.—STEPHEN I. *Corrections*—In the last issue of *Bird-Banding* (Autumn 1977, Vol. 48, No. 4), several errors appeared in the article "Weights and Measurements of Vancouver Canada Geese" by John T. Ratti, Daniel E. Timm, and Fred C. Robards. In addition to several obvious typographical errors in spelling, in Table 1 both "bill length" and "bill width" refer to the nail of the bill; on p 355, line 2, the word "differences" should be changed to "relation-ships"; and Dr. John T. Ratti's present address is Department of Wildlife and Fisheries Sciences, South Dakota State University, Brookings, SD 57006. These errors were caused by a loss of proofs in the U.S. mail.

In the same issue, in the article by George A. Clark, Jr., on p 305, the paragraph on Turdidae should read "Turdidae.—In thrushes the count for III is often 11, except for III-10, 11 in the Gray-cheeked Thrush (*Catharus minimus*) and bluebirds (*Sialia*)." On p 307, 13 lines from the bottom, omit the word "*Catharus*."—Ed.
