COUNCIL MEETING MINUTES — Eastern Bird Banding Association, Pocono Environmental Education Center, Dingman's Ferry, PA, 20 April 1979.

- The meeting was called to order by President Robert J. Pantle at 6:45 p.m.
- Attending: Robert Pantle, Valerie Freer, Will Merritt, Hannah Suthers, Elva Hawken, Davis Corkran, Nadia Mutchler, Kathleen Anderson, Fred Schaeffer, Robert Yunick, Jo Kixmiller, Charl Warburton, Frank Neumann and Robert Merritt.
- Robert Pantle had invited the Committee Chairpeople to attend the Council Meeting and Ruth Rose, Dorothy Bordner, Christopher Rose and Douglas Kibbe were present.
- A proxy from Ted Beckett to Mickey Mutchler was received and recorded.
- Minutes: Minutes of the previous meeting were read. It was noted that two procedures from last year's meeting were out of order: (1) An illegal proxy was given by Roger Foy to Kathy Klimkiewicz. A proxy may only be given to a member of Council. (2) The amendment to By-Laws Article IV, Section 3, regarding membership did not follow the correct procedure of presentation to the President and Secretary in writing at least 30 days prior to the Annual Meeting and to the Council at least 10 days before the Annual Meeting.
- Minutes were accepted with these two notations.

Officers' Reports:

- **Treasurer:** David Corkran reviewed his report. EBBA is financially sound. Dave tendered his resignation after serving 8 years as Treasurer. A vote of appreciation for a job well done was given. Report accepted.
- **Editor:** Mickey Mutchler reported publication is going well. Two questions were asked in her report with the following action taken: (1) Will Merritt moved that Council do whatever is necessary, as soon as possible, to set up a nonsubscribing membership which would give the member an active vote and all mailings and inserts in the Journal, but NO 2nd journal. Passed.
- (2) Hannah Suthers moved that the immediate Past-President serve as chairman of the nominating committee for the following two years. Passed.
- Valerie Freer moved that an honorarium of \$100 be given to the Editor. Passed.

Report accepted.

Standing Committees:

- **Location:** Will Merritt (oral report only) reported no location has been found as yet for the next meeting. Several suggestions were presented and will be investigated quickly so that membership can be advised as soon as possible. Report accepted.
- Finance: No chairman appointed.

- Auditing: Raoul Faralla, Accountant, examined the books, accounts, and records of the Treasurer of EBBA and found them to be true, accurate, and in good order. Report accepted.
- **Memorial Fund:** Robert Leberman No memorial grant was made this past fiscal year, therefore two grants of \$250 each will be advertised for the coming year. It was noted that these awards are open to **all** banders, and not just students. Report accepted.
- **Mist Net:** Robert Merritt Sales of EBBA nets are going well, but the trend seems to be for selling more to organizations and institutions rather than to individuals. Report accepted.
- **Education:** Chris Rose After much discussion of the report, Valerie Freer made a motion that Council approve a followthrough of our application to the National Park Service regarding the site at Sandy Hook, NJ. Chris Rose will act as chairman of a committee to establish a "home" for EBBA. Report accepted.
- **Membership:** Fred Schaeffer A great deal of effort was put forth regarding membership this past year. We now have 797 members of EBBA. Thanks was given to the Bird Banding Laboratory for their prompt and accurate monthly up-

dates to the permit mailing reports. It was also noted that any member who wishes to know names/addresses of other members in their vicinity or in an area they are to visit can get this information from the membership chairman. Inquiries should include the name of the town, county, state, and zip code.

- Help is needed with some of the mailings done by the membership chairman. Several Council members who are geographically close to his area offered their help.
- One thousand new brochures are to be made up which will incorporate the new dues rate and new Treasurer's name. Hannah Suthers made a motion that up to \$300 be made available to the Membership Chairman for expenses. Passed.

Report accepted.

- **Circulation:** Ruth Rose There have been several problems with the postal service at the delivery level, but it is still felt that 3rd class mailing is the best method for the delivery of NABB. It was suggested that a joint comment from the two Editors be included in NABB requesting prompt address corrections or change of address to facilitate correct delivery. It costs EBBA 25 cents for each Post-Office-sent Change of Address. Report accepted.
- Historian: Dorothy Foy No report. B.I.R.D.: Tom Mutchler Orders continue to come in for the manual from all over the U.S. and Canada. There are approximately 150 copies on hand at present. Report accepted.
- By-Laws: Robert Yunick The final By-Laws revision was discussed Article by Article with the following action taken:
- Article I Will Merritt moved adoption of Article I upon approval of the other 14 Articles being here proposed. Passed.
- Article II Will Merritt moved adoption of Article II upon the approval of the other 14 Articles being here proposed. Passed.
- Article III Valerie Freer moved the adoption of Article III upon approval of the other 14 Articles being here proposed. Passed.
- Article IV Will Merritt moved the adoption of Article IV upon approval of the other 14 Articles being here proposed. Passed.
- Article V --- Hannah Suthers moved adoption of Article V with the following addition and upon approval of the other 14 Articles being here proposed: This last sentence is to be added — "Twenty-five (25) members assembled and voting shall constitute a quorum." Passed.
- Article VI --- Will Merritt moved adoption of Article VI upon approval of the other 14 Articles being here proposed. Passed.
- Article VII Will Merritt moved the adoption of Article VII with the following wording changes and upon the approval of the other 14 Articles being here proposed: Section 3. Special meetings of Council may be called by the President, or by the Secretary at the written request of four (4) members of Council and shall require written or oral notification of all members of Council at least fourteen (14) days before the meeting. Section 11. A member of Council who cannot attend a council meeting may give a proxy in writing, with appropriate voting instructions, only to another member of Council. This proxy shall be exhibited to the Secretary at the beginning of the meeting and the fact recorded in the minutes. Each member of Council is entitled to one vote and one vote for each proxy as recorded with the Secretary in such Council member's name. Passed.
- Article VIII Robert Merritt moved adoption of Article VIII with the following change and upon approval of the other 14 Articles being here proposed: Section 5. Second paragraph. The Secretary shall keep in the minute book a separate, complete and chronological record of all amendments to these By-Laws. In the absence of the Secretary from any

meeting of the Association, the P -si lent shall appoint one of the Council members to serve as Secretary pro-tempore. He shall, at the expiration of his term of office, removal or resignation, tender all books, papers and all other property of the Association, to his duly elected successor in office, or to such person or persons as are designated by Council. Passed.

- Article IX Will Merritt moved adoption of Article IX upon approval of the other 14 Articles being here proposed. Passed.
- Article X Will Merritt moved adoption of Article X with the following change and upon the approval of the other 14 Articles being here proposed: Section 4. ELIGIBILITY: The proposed study shall use bird banding techniques or bird banding data. Passed.
- Article XI Will Merritt moved adoption of Article XI upon approval of the other 14 Articles being here proposed. Passed.
- Article XII Will Merritt moved adoption of Article XII upon approval of the other 14 Articles being here proposed. Passed.
- Article XIII Kathleen Anderson moved adoption of Article XIII upon approval of the other 14 Articles being here proposed. Passed.
- Article XIV Will Merritt moved adoption of Article XIV upon approval of the other 14 Articles being here proposed. Passed.
- Article XV Hannah Suthers moved adoption of Article XV upon the approval of the other 14 Articles being here proposed. Passed.
- Hannah Suthers made a motion that Council accept the By-Laws as amended and offer them to the membership at the Annual Meeting for their approval. Passed.
- Will Merritt moved that Council express the gratitude of EBBA to Bob Yunick for his tremendous job of revising the By-Laws. Passed. Report accepted.

New Business:

- Hannah Suthers submitted a proposal for chapterization which asked for the development of an amendment to EBBA By-Laws that will effectively and easily allow Chapters to be formed under the aegis of EBBA with benefits to both. Frank Neumann moved that a committee be formed to study the chapterization amendment to the By-Laws. Passed.
- Charl E. Warburton was named as Association agent and her home address of Mine Road, Box 332D, Pennington, NJ 08534 will be given as principal office of EBBA.
- Bob Yunick made a motion that honorary memberships be awarded to Raymond Middleton, Mr. & Mrs. William Pepper, LeRoy Stegeman, Grace Meleny and Dorothy Mendinhall. These honorary memberships will be given out Saturday evening. Passed.
- Bob Yunick made a motion that Council authorize the By-Laws committee to revise Article IX, Section 11 to provide continuity to the position of membership chairman by allowing for this position to be part of a Councillorship and that their recommendation be made at the next Council meeting. Passed.
- Valerie Freer made a motion to elect Mickey Mutchler as Editor for the coming year. Passed
- Will Merritt made a motion for adjournment at 11:46 p.m. Passed.
